Sub: **Enabling Provisions in NREGASoft for payment of additional wages to the beneficiaries under MGNREGS in respect of 20 Migration Prone Blocks of the 4 Districts.**

Ref: **This Department Notification No. 1602 dated 21.01.2020. (Copy Enclosed)**

Madam/ Sir,

In continuation to this Department Notification referred to above, I am to say that Ministry of Rural Development, Government of India has enabled the following provisions in NREGASoft to facilitate the measures adopted by the State Government in 20 Migration Prone Blocks of 4 Districts under MGNREGA.

1. The expenditure on the additional days over and above 100 days work mandated under MGNREGA shall be paid through State fund. For this purpose, State Govt. has released an amount of Rs. 100.00 crore as 1st installment for expenditure on wages @ 286.30 to the State e-FMS account for payment.
2. For the mandated 100 days of work under MGNREGA, additional Rs. 98.30p. over and above Rs. 188.00 will be borne by the State and the amount paid additionally in this component shall be paid from the Ne-FMS account.

Accordingly, the Districts are to maintain the report of expenditure done for additional days & wages in the notified Blocks and furnish the same in the prescribed format as provided at Annexure-I on weekly basis starting from 21st January, 2020 on each Tuesday by 4 P.M.



NOTIFICATION

Pursuant to Para 9.1 of MGNREGA Annual Master Circular 2019-20 of Ministry of Rural Development, Government of India and in order to arrest distress migration, the Government of Odisha have been pleased to notify the wage rate for unskilled manual worker under MGNREGS as **Rs.286.30 p** (Rupees Two Hundred Eighty Six and Thirty Paise only) in respect of the **20 migration prone Blocks of the 4 Districts (Annexure-I)** during FY 2019-20.

1. The Job Seekers under MGNREGA in the 20 migration prone Blocks of the 4 Districts will be paid additional wages of **Rs. 98.30 p** over and above the wage rate notified under MGNREGA i.e. Rs. 188/- to commensurate with the notified minimum wages for the unskilled workers in the State i.e. **Rs. 286.30p** per day. This additional amount of **Rs. 98.30 p** will be borne by the State Government.
2. The State Government will provide **additional 100 days** of work over and above the stipulated 100 days work mandated under the MGNREG Act, 2005 in the 20 migration prone Blocks of the 4 Districts. The entire cost towards payment of wages @ Rs. 286.30 p for additional 100 days will be borne by the State Government.
3. The above provisions have been enabled by Ministry of Rural Development, Government of India in NREGASoft to facilitate payment of wages as per the revised wage rate of Rs. 286.30 p in respect of the 477 GPs under 20 migration prone Blocks of 4 Districts i.e. Balangir, Bargarh, Nuapada & Kalahandi.
4. All vulnerable households, prone to distress migration shall immediately be identified and provided wage employment under MGNREGS.
